SpyWare

What should you do?

SpyWare is a problem and a half. You can have your computer slow down, render information to company(s) and worst of all, it can leave a backdoor for viruses.

How do you know if you have spyware? SpyWare comes in as you go to websites that have pop-ups or downloaded files. They are very covert in their actions.

When you find your machine slowing down, especially on the internet, or it just is taking a lot of time to execute programs, then these are signs that the “cloak and dagger” software is at work.

What can you do about it? One thing is that first, you should consult Task Manager (right-click on taskbar and click on Task Manager) and see if your computer is at 99 on System Idle. That is a very good sign that something is up.

The best thing to do is rid the system of SpyWare by installing an anti-SpyWare program such as Ad-Aware™ or SpyBot™. When you root it out, then your computer will increase performance.

Next, use your anti-virus software and check your pc for viruses. Viruses use program code to write themselves into a file or embed code in an email.

Go to Symantec or McAfee to see if there are any current updates or warnings of viruses making the rounds. Always use your anti-virus and keep your Firewalls up!

Take this warning to heart, it may even effect you.

PhotoSuite offers a dozen templates, including Tropical Getaway, Office Events, and Valentine's Day. By default, all templates should be visible, but if not, click All Folder in the Guide panel to see them. In the Work area, select the template you'd like to use and click Next.

One of the reasons we here at *Smart Computing* consider Roxio PhotoSuite such a user-friendly piece of software is that it lets the user create, in minutes, projects that might take hours offline. So put away the glue, the markers, the construction paper, and the stacks of photographs and get ready to create a collage using the PhotoSuite CollageCreator.

To begin, select Edit & Create from the home page and then choose Projects. Select Collage on the Guide panel and click Next. You have two options—to create a collage from scratch or to use one of PhotoSuite's templates—so for your first project, let's go with the easier of the two. Click the radio button next to Pre-designed Template and click Next.



You can also change the layout of the photos. Because PhotoSuite doesn't analyze the content of the photos, but simply places them randomly according to size and shape, it's possible the layout won't be exactly how you want it the first time. Click the Shuffle button to randomly change how the photos appear.

In addition, the More Settings button lets you make further modifications. Place a check mark in the Offset box to randomly alter the extent to which each photo is offset from its random location. Place a check mark in the Rotation box to randomly alter the angle of rotation for each photo. Place a check mark in the Size box to randomly alter the size of each photo. Lastly, place a check mark in the Layout box to randomly alter how the photos lie on top of one another.



Once you've found a layout that's relatively close to what you want as a final product, it's time for even further enhancements, and this is where you can make the difference between a collage that's almost perfect and one that's exactly how you want it. You don't have to rely on PhotoSuite randomly assigning a photo's size, rotation, or location; you can control those features yourself.

Share Your Files and Go Directly to Jail?

Music, movies and similar artistic products have long been protected by the federal copyright laws. Under these laws, if you use or distribute such materials without permission of the copyright owner, you can be sued - as many file sharers discovered when they found themselves named by the Recording Industry Association of America (RIAA) in mass lawsuits, most of which resulted in settlements for several thousand dollars each.


Now our legislators want to take it further and criminalize such activities rather than leaving them (solely) under the jurisdiction of the civil system. The House Judiciary Committee recently approved a law that will make unauthorized sharing of music, movie and software files not just a tort, but a crime. That means you can go to jail for it.

Now, distributing pirated files commercially has been

prosecutable for a long time, but those who gave away their files for free have generally fallen under the civil system. If the bills coming up before Congress pass, not only the file sharers but the companies - such as Kazaa - that distribute peer-to-peer file sharing software may find themselves facing loss of liberty as well as monetary penalties. These laws are, of course, heavily supported by many big players in the music, movie and software industries and, just as predictably, are opposed by advocates of the "information wants to be free" philosophy and would-be Robin Hoods who see file sharing as a modern day form of stealing from the rich to give to the poor. Many of us, however, see danger at both ends of the spectrum. Intellectual property rights are important in an era when millions of people make a living through the production of creative non-tangible material such as songs, books, screenplays and computer programs. Insisting that anyone should have access to their material without paying for it makes no more sense than insisting that car manufacturers be forced to give away the vehicles they make to those who can't afford them or just don't want to pay.

On the other hand, a song is not the same as a car or

other physical property. When you copy it, you don't deprive the original owner of its use (which has traditionally been a required legal element of the offense of theft). Assuming you aren't repackaging and selling the copied song for profit, there is no demonstrable provable loss to the original owner. Much as the industry might proclaim otherwise, there is no evidence that all, or even some, of the people who download "illegal" songs would have bought the music if the downloads weren't available.



And there are real problems that arise from criminalizing everything that we believe is morally or ethically wrong. Taking this trend to its natural conclusion would result in putting people in jail for telling lies or hanging them for committing adultery. Laws are necessary to prevent chaos and preserve an orderly society. . But an overabundance of criminal laws creates an oppressive society in which the government controls our every move. The civil court system was designed to deal with those disputes between

entities and individuals (for example, between the RIAA and file sharers) in which one party believes itself to have been "wronged" by the actions of another. It's served that purpose well in the past.

The Piracy Deterrence and Education Act of 2004 is one of the most prominent of several Internet-related bills that have been voted on in Congressional committees over the past few weeks (see <http://www.winxpnews.com/rd/rd.cfm?id=040921ED-Piracy> for more information).

Other measures passed by the same committee would target the placement of spyware on users' computers without their knowledge. And of course, the CAN SPAM act led the way.

Let us know what you think about the move to criminalize everything from sharing a file to sending unwanted advertising. Are there differences between placing spyware, sending spam and sharing files? Is there a difference between putting your music "out there" for everyone on a P2P network and making a single copy for a friend? Should any, all or none of these be criminalized? You, dear reader, may now enroll, online, to take classes from, of all places, **The Massachusetts Institute of Technology**, and do so **WITHOUT COST**, or as we like to say, **FREE!**

It's called MIT Open CourseWare. It is a free, open publication of MIT course materials. No registration is required. At present there are 900 courses available ranging alphabetically from Aeronautics & Astronautics to Writing & Humanistic Studies. Eventually this University expects to have ALL its courses as part of this program. Of course, you won't get a degree or a certificate, nor will you have access to MIT faculty. There are some expenses, you need to have course materials (books, videos, mags, notebooks, pens, etc.) but you probably can skip the backpack. But since you live at home and no tuition is required, you might consider a ski mask since you're making out like a bandit.

Courses are listed in the left hand column of opening page. I selected *Media Theater Arts*, an undergraduate course. *Composing with Computers, Course 21m.361* includes: Lectures and Labs. There's a syllabus, calendar, readings, labs.

MIT OCW goals are to provide free, searchable access to MIT course materials for self-learners around the world.

A 4-year scholarship to MIT is worth in the neighborhood of 30 to 40 thousand dollars plus living expenses and course materials.

Easy to sign up for. I'm a member, 22 September 6:37 pm CDT.




