embedding true type fonts

If you create a document that you want to share with others, it is helpful for the other people to have the fonts you use within your document.

If they don't have the fonts, then Word substitutes a similar font for the original fonts you used. The result may not be to your liking. One solution is to include the fonts with your document. You can automatically embed some types of fonts by following these steps:

- 1. Choose Options from the Tools menu. Word displays the Options dialog box.




Figure 1. The Save tab of the Options dialog box.

 - 2. Make sure the Save tab is selected. (Figure 1.)

- 3. Ensure the Embed TrueType Fonts check box is selected.
- 4. If you will be using a small number of characters in a particular font, choose the Embed Characters In Use Only check box.
- 5. To save space in the document, choose the Do Not Embed Common System Fonts check box.
 - 6. Click on OK.
 - 7. Work with your documents as normal.

You should realize that embedding fonts can increase the size of your document files. In fact, if you use a lot of fonts, it can increase the size drastically. In addition, not all fonts are "embeddable." Some fonts are protected by their creators against distribution by embedding. If you are curious about whether a particular font can be embedded, you can either contact the vendor or download a free Font Properties Extension Tool from Microsoft. You can download it at the following address:

The tool updates Windows so it displays more information when you right-click on a font file and choose Properties. One of the pieces of information displayed is whether the font is protected or not. If it is protected, it cannot be embedded in a Word document.

specifying the behavior of the enter key

hen you type information into a cell, it is normal to press the Enter key at the end of your entry. Excel allows you to specify exactly what should happen after you press Enter.

Basically, you can specify that nothing happen (the cell into which you entered information remains the currently selected cell) or that a different, adjacent cell is automatically selected.

To make your specification, follow these steps:

- 1. Choose Options from the Tools menu. Excel displays the Options dialog box.




Figure 1. The Edit tab of the Options dialog box.

- 2. Make sure the Edit tab is selected. (See Figure 1.)
- 3. Either select or clear the Move Selection After Enter check box, depending on whether you

want the selection to move or not when pressing Enter.

- 4. If you select the Move Selection After Enter check box, use the Direction drop-down list to specify the direction of the cell that should be selected.
 - 5. Click on OK.

Question: My eyesight is failing and I find it very difficult to enlarge the font in order to read my email online. Is there another way?



nswer: Yes, you can easily ENLARGE the font in an online email as follows: Hold down the CTRL key and scroll with the mouse wheel. This works on most websites and other software as well.

Question: When typing the temperature I would like to insert a "degree" symbol automatically instead of writing the word "degrees." Is there a shortcut for this symbol?

Answer: Yes, there are two shortcuts for the degree symbol.

- 1. Hold down the ALT key and type 0176 on the numeric keyboard. The degree symbol will appear immediately ° You must use the numeric keypad to type the numbers and not the keyboard. Make sure that the NUM LOCK key is on if your keyboard requires it to type numbers on the numeric keypad.
 - 2. AutoCorrect has a predefined keyboard shortcut

for creating a degree symbol. Press CTRL+@, then press SPACEBAR.

Question: When I am typing an email or a document in Word on my laptop my mouse jumps to another line and I find myself typing in the middle of another sentence. Why does this happen and can it be corrected?

Answer: When using a notebook with a touchpad and a mouse attached, your thumb may get too close to the sensitive touchpad. This will cause the insertion point to jump to another line.

To prevent this you can disable the touchpad in Control Panel > Mouse > Touchpad tab, and just use the mouse. If you prefer to use the touchpad, look for a setting on the Touchpad tab to make it less sensitive.

free utilities to boot and repair "crashed" pcs

ne day last week I received a phone call from a prominent media personality asking for help; his Windows 7 computer would not fully boot into either normal Windows mode or safe mode. During the boot process it would either spontaneously reboot before the desktop loaded, or would start to boot when the infamous "Blue Screen of Death" flashed on for just a second or two, and then the computer would self-reboot, and fail again.

I went to his house and found that he had a custom built Windows 7-64 "Professional" machine that was assembled for him by a major local computer store. The machine was about three years old, and had been problem free until this incident occurred.

My first steps in trying to get his computer to boot was to carefully observe his boot process, trying to read the error codes on the "Blue Screen" before they flashed off. After several reboots, I noticed that the error codes were inconsistent, as they were different with each reboot.

After several unsuccessful attempts to boot into safe mode, trying safe mode by itself, safe mode with networking, and safe mode command prompt,

I finally was able to boot once into regular safe mode. I asked him if he had installed any new software or hardware recently prior to this problem, and he said no. I went to System Restore and found a restore point from a few days prior to this boot problem, checked the utility to see if any files were in jeopardy (none were), and ran the system restore. The process appeared to complete successfully, and rebooted the computer, but the problem continued; it was in an "infinite loop" of boot — reboot.


I tried several times again to boot into safe mode (F8), with only temporary success. I tried to check his startup using MSCONFIG, but the computer often self-booted too quickly to accomplish the task; after about the fifth attempt, I was able to uncheck everything unnecessary and save the revised startup settings just before the computer rebooted itself again.

Fully aware that if it was a malware problem that had impacted his startup process, the malware might not show up in the startup listing. I inquired as to the security system that he had installed on the computer; he replied with the name of a major, very popular, freeware antivirus product. I inquired if it was just the antivirus utility or the entire security suite, and he informed me that it was just the antivirus product.

Now I became even more suspicious of the cause of his boot problem, as viruses are now only a small minority of contemporary malware threats, and traditional antivirus software, even when frequently updated, may not provide any protection from the myriad of threats being widely circulated.

I proceeded to boot his computer using a bootable CD that I had with me so I could backup his critical personal files to his external USB hard drive using the included backup utility, and then run several repair utilities that have worked well in the past to boot previously unbootable computers. The bootable CD that I had with me was a well regarded commercial product (not freeware) that had been recently sent to me for review and testing.

Despite running each of the included utilities, followed by an *Turn to next page*

on-screen confirmation that they appeared to be successful making changes to his hard drive and critical system files, his computer still would not successfully reboot. Stymied, I offered to return with some additional utilities.

There are some excellent freeware utilities that can be used to create bootable CDs (and in some cases bootable USB drives), and contain a wide variety of repair and recovery utilities.

Since they are frequently updated, I chose to download and create fresh CDs of each, rather than use the older CDs that I already had. While most of the computer security software publishers, such as Trend-

Micro (TrendMicro Rescue Disk) and Kaspersky (Kaspersky Rescue Disk 10), offer a free downloadable utility to create a bootable CD that can detect and clean a malware infected computer, a process that is often adequate to enable a heavily infected computer to successfully reboot, my personal preference is for a bootable CD that can scan for malware as well as offer additional repair utilities that may be useful in repairing damage caused by malware or other issues.

My preference is to create bootable CDs rather than bootable USB drives because virtually any CD drive equipped PC can be booted with a CD, but only some of the newer PCs support booting from a USB drive.

While I commonly create four or five different bootable CDs in order to deal with almost any reasonable contingency, there are two that are my primary "go to" CDs. In the event that there might be a malware problem influencing a boot problem, my personal choice is the AVG Rescue CD (avg.com/us-en/avg-rescue-cd), a 106MB download that is an ISO formatted file. ISO files cannot simply be burned or copied to a CD to make it bootable, but must be created using the ISO function included on most CD burning utilities, or by using the excellent free ImgBurn utility (imgburn.com) which will quickly and easily utilize the ISO file to create a bootable CD.

For those who may prefer a bootable USB drive, a version of AVG Rescue is available that can be used to create a bootable USB drive; for either choice, AVG offers a You-Tube with simple instruction on how to use the Rescue service at youtu.be/fGX-592qty8.

Once the bootable device, CD or USB is created, the computer is booted with that device; some computers may need to be set in the BIOS or boot selection choices in order to boot from the chosen device. Once booted using the Rescue CD or USB, a license agreement will be displayed, all hard drives mounted (become accessible), and the AVG will go online in order to download any updates.

After following the on-screen prompts (it may be necessary to use the cursor keys, up, down, right, or *Turn to next page*

left), the hard drives can be scanned and the detected malware removed, renamed (typically prevents it from reloading), or ignored. After the successful removal of malware, return to the main menu and select the "Miscellaneous Utilities" if desired; these miscellaneous utilities include a selection of diagnostic programs, file management tools, troubleshooting programs, and repair tools.

In my experience, this AVG Rescue CD (or Rescue USB) is typically adequate to clean an infected PC from malware and restore it to operating condition.

For someone that wants "everything including the kitchen sink", there is an incredibly powerful free utility "Ultimate Boot CD" (ultimate-bootcd.com) that may create what is generally accepted as the most comprehensive set of free repair and recovery tools available on any free bootable CD. A huge download, a 561MB ISO file, this file can be used

to create a bootable CD using Img-Burn or the ISO function available in most CD burning utilities.

For those who prefer creating and using a bootable USB drive, detailed

instructions are found under the heading "Making UBCD memory stick" online at ultimatebooted.com/customize.html.

What is so amazing about this "Ultimate Boot CD" is the enormous selection of over 100 diagnostic and repair programs that are included on this CD (or USB drive).

When I first boot with the Ultimate Boot CD, I typically perform a malware scan using the included F-PROT and ClamScan security software, cleaning any detected malware, and then using any necessary additional utilities to accomplish my task of repairing the computer, unless the problem is primarily a hardware problem and not a software problem.

While there are often multiple utilities on the Ultimate Boot CD that can perform the same basic functions, the included utilities can be used to reset the BIOS, clean the CMOS, test the CPU chips, examine and repair the master boot record (MBR) and other bootable sectors of the hard drive, reset system passwords, edit and repair the registry, diagnose and manage the hard drives (both generic and brand specific), copy or clone the hard drive, edit or wipe the contents of the disk, install a new hard drive (both generic and brand specific), repair or reset a hard drive partition, test the PC's memory, scan for malware using multiple anti-malware programs, test the video card and other peripherals, test overall system performance, and generate detailed reports about the computer's hardware.

CD is a huge collection of over 100 additional utilities included in the "Parted Magic" collection.

This "Parted Magic" group of utilities (partedmagic.com/doku. php?id=programs) provide extensive extra functionality including hard drive utilities, file system tools, boot loaders, dozens of practical utilities (X Utilities) that enable traditional computer functionality without Windows being loaded, and dozens more "Console Utilities" that offer the user the ability to perform other diagnostic and repair functions.

I have found Ultimate Boot CD to be a most valuable and useful tool in diagnosing and repairing problem computers, and the AVG Rescue CD an effective bootable CD in cleaning the malware from badly infected computers and restoring the computer to full functionality.

With both of these free bootable CDs (or bootable USB drives), any technically competent user can easily diagnose and repair most software related problems that may have previously rendered a PC un-bootable.

Icd resolutions

CD monitors are super. They're flatter, lighter, and let's face it, cooler than the bulky old CRTs out there. However, unlike CRTs, LCDs look their sharpest at their native resolutions, such as 1,280 x 960 or 1,600 x 1,200 pixels, as listed in their users' manuals. If you have your computer's display settings set to a different resolution, onscreen text and graphics may appear slightly fuzzy. On the other hand, the native resolution may be so fine relative to the physical size of the screen that onscreen objects may be way too small for your tastes. If the labels of your icons are too tiny to read at the LCD's native resolution, try lower settings until you find a resolution that's reasonably sharp. If you are the market for a new monitor, look around for a touch screen which will make you ready for Win 8 when you get it.

adjust monitor brightness

Since we are on monitors let me ask: Do your eyes hurt after sitting at your computer, it may not just be from spending too much time staring at your screen. An overly bright monitor (particularly in a dark room) can be uncomfortable for some users. Check your monitor's sides and bottom (of the screen, rather than the stand) for buttons that will let you lower the display's brightness setting.

log out quickly

If you regularly log out of your Windows XP/Vista computer instead of shutting it down, try this handy key combination to quickly switch user accounts or "lock" your computer, depending upon your security settings. Press the Windows key (next to the ALT key on many keyboards) and L at the same time. You'll still be logged on, but you'll be able to switch user accounts. If your account requires a password, your PC will be "locked" until you supply it. When you return to the same account, you'll see the same documents and applications that were open before you pressed Windows-L.



wep and wpa

You probably already know that you shouldn't set up a WLAN (wireless local-area network) or Internet connection without protection in the form of encryption. What you may not realize is that WEP (Wired Equivalent Privacy) encryption is no longer enough in the eyes of most experts. WEP may discourage casual attempts to connect by nearby users that detect your WLAN's presence, but it won't keep out skilled and determined hackers. A better choice is WPA (Wi-Fi Protected Access), which adds several layers of protection beyond WEP. To use it though, you'll need WPA support in both your router or access point and your computer's wireless adapter.

convert to print or web

Microsoft Publisher's Convert To Print and Convert To Web Publication options let you change a print publication to a Web publication and vice versa. Open the publication you want to convert and click File. Next, click either Convert to Web Publication or Convert to Print Publication and follow the instructions to make the switch. As a word of caution, certain features available in one publication type may not be available in the other, so your publication may experience a few formatting changes when you convert it.

take a screenshot in word

Microsoft Word 2010 provides you with the capability to take a screenshot from another open program and paste it within Word. Just click the Insert tab and select Screenshot.

gadwin screen capture

Since I mentioned the Word 2010 screenshot capability, I thought I would mention Gadwin Screen Capture. This is a free download (just Google Gadwin) and allows you to take a screenshot of a window at any time. You can be on the internet, browsing a PowerPoint presentation or any time you want to capture something on the screen. Once loaded it works when you hit the printScrn button. (I think the latest version has you hold down the Control key at the same time). You can set up the name of the capture and whether you want to capture it to the clip board or to a PrintScreen folder, or both. What you end up with is a jpg or bmp picture. If you take a picture of a document you can always use a free OCR program to convert it to actual text. One thing you must do is set it for 'rectangle' while you are setting it up. This way you can capture any size portion of the screen – from full monitor to a small rectangle containing just what you need. I know there are Turn to next page other screen capture programs out there, but I have been using this one for many years and it works simply and flaw-lessly.

background removal tool

Need to quickly remove the background from an image? With the Background Removal Tool in Microsoft Word 2010, you can clean up the background to make your image blend with the document.

recall a message in outlook

Catch a spelling error right as you were sending out an



email? If you are using Microsoft Outlook, you can recall the message. Open your sent messages, open the email you want to recall, select Actions (located in the Move section of the ribbon), and click Recall This Message.

put recent items on the start menu

Windows 7 has a Recent Items feature, which can display any documents you've recently used. To put this button on your Start Menu, click Start and then right-click the Start menu. Click Properties. When the Taskbar And Start Menu Properties window opens, click the Start Menu tab and then click the Customize button. When the Customize Start Menu button opens, scroll down to Recent Items and check its box. Click the OK button. Click the OK

button on the Taskbar And Start Menu Properties window. Now, click the Start button. You'll see the Recent Items button on the right side of the Start Menu. Hover the mouse over Recent Items (or click it) and you'll see

the list of recently used documents. Click any document in the list to open that item.

go incognito

If you are using a friend's computer and don't want your browsing history to remain on his PC after you leave, you might want to use Chrome's Incognito window. It prevents the PC from retaining most traces of your browsing. (It won't, however, prevent a keystroke capture device from tracking your keystrokes.) To use the feature, click the wrench icon and then click New Incognito Window.

do green bars in the defragger mean my bios has a virus?

You local advisor tells me I have a virus in my BIOS, which cannot be removed; at least, not by Norton. Proof of the virus, he insists, is that I have two green columns in the dialog box of my disc defragmenter. He further insists that the green will continue to expand until my PC fails completely.

A second advisor insisted the second green column could be eliminated by going to Systems, Performance, Virtual Memory and clicking "No page file." I tried several times. As soon as I restore the page file, the second green column reappears. Then, he suggested Page Dfrag.zip. It also failed to eliminate the second green column.


At that point, his confidence failed and he too leaned to the virus as the most probable explanation. Is this a situation which should worry me? My PC is five years old and is running fine. I have Norton 360 v4 on Windows XP. My C: drive has 290 GB cap and 280 GB free space at present.

think it's time to find new advisors. Those green bars are normal and expected. They don't indicate a virus at all, BIOS or otherwise. And the advisor who suggested that they do is just plain wrong. I'll show you what they do indicate.

green bars

To make sure that we're all talking about the same thing, here's an example of green bars in the Windows XP defragging program:



This happens to show one large bar, but, in fact, it could be several green bars or lines throughout the display. Green lines do not indicate a virus.

Period.

As the legend at the bottom of that very window tells you, the green bars indicate "Unmovable files;" nothing more, nothing less.

unmovable files

So, what's an unmovable file?

Well, your second advisor was at least on the right track. Unmovable files include things like the system paging or virtual memory file, the registry and other files that Windows has locked for exclusive use while it's running. If Windows has them locked, then the defragging utility can't defrag them.

Sure, removing your paging file may well make some of the green bars go away. By not having a paging file at all, there's nothing for Windows to lock. But that's rarely the correct solution. Most machines need a paging file configured to run properly.

Besides, getting rid of green bars isn't really a useful goal. As I said, they just represent a few files which the defragger can't move.

That's OK.

page defrag

Running Page Defrag could certainly reduce the number of green bars. It does so by defragging the paging file and other files before Windows actually runs.

Remember that defragging is all about taking the various parts of a file that might be scattered all over your hard disk and moving those parts so that they are all right next to each other. This helps speed up disk access.

Defragging the paging file might move two or more of those green bars next to each other so that they then appear as a slightly larger single green bar.

That's all.

what about a bios virus?

A BIOS virus is highly unlikely.

BIOS viruses exist, but they're very rare. They're not of great value to hackers who can typically infect many more machines with much less work using a more traditional virus.

At this point, I'm afraid that I can't trust the judgment of your first advisor who seemed to think you have a virus simply because the defragger showed some unmovable files.

As I've said, they're completely unrelated.

Oh yeah. I used Notepad.

This is waaay easier!

t's probably safe to say that everyone has copied text from a webpage at some time and pasted it into an email or into a Word-like program. So, of course, you can relate to my dismay of pasting the type complete with its formatting riding piggyback on it.

I always have to stop what I'm doing and unformat and reformat the type, so it blends in with what I'm working on.

I can hear "old timers" yelling, "Notepad! Use Notepad!"

That's true. And, it's a good option. I'm using Windows XP (still), so I have a shortcut to Notepad on my Start menu. It's very easy to click on Start while I have my browser open and click to open Notepad to paste the web text, then recopy it from Notepad, and repaste the text into a document.

But, I found a simpler method. Really. There is no learning curve.



I only have to click once after copying from a webpage and then I can immediately paste unformatted text into anything anywhere!

With our typical complicated programs to work with, this just doesn't seem possible. Or, maybe alchemy might be involved!

The short of it is that this is true, no hocus pocus. It is possible with a tiny program called Get Plain Text.

It's only 70Kb and it doesn't add an icon to your system tray or grab any memory when you use it.

It works in less than a second to remove text formatting, including fonts, sizes, colors, and embedded images. It just leaves plain text.

Download the program from the developer at http://clipdiary.com/getplaintext/?s=internetshortcut&

utm_nooverride=1 or a secondary download site at http://www.softpedia.com/get/PORTABLE-SOFTWARE/Office/Clipboard/Portable-Get-Plain-Text.shtml. Save it to your preferred disk location. Click on the program to run it. Add the icon that launches Get Plain Text to your Quick Launch bar or favorite program launcher.

I keep it on my Quick Launch bar. As soon as I copy something to the clipboard, I click on the Get Plain Text icon. Then, I paste the text anywhere I desire. That's it.

When I use Get Plain Text, no window opens. There are no dialog boxes or preferences to select. There are no flags, bells, or whistles to tell me it is finished. It simply works fast, silently, and unobtrusively.

Did I mention — it's free!

Subsequently, the Firefox Live website was retired.

verizon's plan to break the internet

Verizon...is trying to overturn the Federal Communications Commission's Open Internet Order, which prevents Internet service providers from blocking, throttling or otherwise discriminating against online content.

And in court last Monday (September 16), Verizon lawyer Helgi Walker made the company's intentions clear, saying the company wants to prioritize those websites and services that are willing to shell out for better access. She also admitted that the company would like to block online content from those companies or individuals that don't pay Verizon's tolls.

In other words, Verizon wants to control your online experience and make the Internet more like cable TV.

This approach would undermine Net Neutrality, the principle that allows us to connect and communicate online without interference.

In court last week, the judges asked whether the company intended to favor certain websites over others.

"I'm authorized to state from my client today," Verizon attorney Walker said, "that but for these rules we would be exploring those types of arrangements."

While Verizon and other ISPs are already raking in immense profits from connecting users to the Internet, they see even higher margins in being able to tell us where to go once we're online. By charging a premium so wealthy businesses can jump to the front of the line, they're playing a game with data delivery that would shove all other sites to the back.

"I think the people who talk about dismantling — threatening — Net Neutrality don't appreciate how important it has been for us to have an independent market for productivity and for applications on the Internet," World Wide Web inventor Sir Tim Berners-Lee has said.

Indeed, Berners-Lee built the World Wide Web on an open protocol that gives everyday users the power to go wherever they wish.

This approach has given us a truly free marketplace of ideas where even the smallest entrepreneur can compete with giant corporations. (Would we have many of the Internet's most innovative businesses — like Twitter, YouTube and FourSquare — had they been unable to enter the market on a level playing field?)

The Internet will look a whole lot different if network operators get to favor one online business or speaker over another. We can't let the Verizons of the world turn the Web into their own private fieldoms where they award express service to their corporate allies and shunt everyone else to the side.

Verizon has put its cards on the table. Under its preferred scenario, the open Internet no longer exists. Whatever the outcome of this court case, we need to fight for policies that protect the open Internet — and stop Verizon's vision from becoming reality.
